MEMORANDUM OF UNDERSTANDING

This Agreement made and entered into on this day of April, 2016; between Department of Electronics, Don Bosco University (hereinafter called University) situated at Guwahati, Assam, an Institute of academic excellence; and Tevatron Technologies Pvt. Ltd. , situated at A-22 Sector 3 , Noida-201301 (hereinafter called " COMPANY " which expression shall include its successors and permitted assignees) with its registered office at J-522, Plot No Gh-04, Sector 119, Noida-201301 .

1. OBJECTIVES OF THE MOU


The objective of this Memorandum of Understanding is:

- a) To promote interaction between University and COMPANY through Competency Creation with Skill Development Program and solution offered by COMPANY for University students on-campus, On Line & Off Campus program.
- b) To provide a formal basis for initiating interaction between University and COMPANY.
- c) To Assist to University to set up CoE lab in IoT (Internet Of Things) domain.
- d) Provide platform for deserving students of University for Industrial Internship
- e) Provide Industry Interaction and Project Execution support to students and update on latest emerging technologies to University's students

2. PROPOSED MODES OF COLLABORATION

University and COMPANY propose to collaborate through

For Tevatron Technologies Pvt. Ltd

- a) Summer Training and Internship Program offered by COMPANY for University students on-campus at University Campus for two week duration
 - I. Basic Training will be covered through On-Line Program
- b) Company would be Industry & Execution partner for running following "Certificate Program"
 - I. VLSI Certificate Program for 6 Month
 - II. Certificate Program in IoT for 6 month
 - III. Certificate Program for School teachers in "STEM-Robotics"
- c) Any other appropriate mode of interaction agreed upon between University and COMPANY from time to time

3. FINANCIAL, INFRASTRUCTURE & CO-ORDINATION ASPECTS

- a) Students registered under on campus STIP-2016 will be charged Program Fee_of Rs 3500/- per student, (**Inclusive of Service Tax@12.36%**). STIP-2016 will be of two week Duration.
- b) As the COMPANY is running the Program at University on Campus, so a class/lab with sufficient equipment, PC/laptop per student needs to be arranged by University
- c) The execution of STIP-2016 Program would be full responsibility of COMPANY. COMPANY will however need active coordination/support of faculty and staff for reserving and identifying suitable slots for conducting STIP-2016 sessions.
- d) Food & Accommodation for Tevatron Engineer would be borne by University

4. CONFIDENTIALITY

During and for a period of one year from the date of disclosure, each party agrees to consider as confidential .All information disclosed by the other party in written or tangible form or, if orally disclosed confirmed in writing within thirty days of disclosure and identified as confidential by the disclosing party.

The obligations above shall not extend to any confidential information for which the receiving party can prove that this information is in the public domain at the time of disclosure or comes within the public domain without fault of the receiving party.

5. NON-EXCLUSIVITY

The relationship of the parties under this MOU shall be nonexclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or collaborations of any kind.

6. TERMS AND TERMINATION

This MOU, unless extended by mutual written agreement of the parties, shall expire 1 year after the effective date specified in the opening paragraph. This MOU may be amended or terminated earlier by mutual written agreement of the parties at any time.

7. SIGNED IN DUPLICATE

This MOU is executed in duplicate with each copy being an official version of the Agreement and having equal legal validity.

BY SIGNING BELOW, the parties, acting by their duly authorized officers, have caused this Memorandum of Understanding to be executed, effective as of the day and year first above written.




